- ✓ No alcohol or firearms are permitted at Pardon Gray and no smoking of any kind is permitted.
- ✓ No vehicles will be allowed in exhibit areas between 9:30 a.m. and 4:00 p.m.
- ✓ Vendor setup must be completed by 9:30 a.m. and take down may not begin before 4:00 p.m.
- ✓ **Neither the Tiverton Land Trust nor the Pardon Day Committee is responsible for any losses, costs, damages or claims by or against any Exhibitor resulting from any theft, injury, property damage, inconvenience, act of God, or otherwise and any such claims are the sole responsibility of the Vendor. To the greatest extent permitted by law, the undersigned exhibitor and its agents and representatives (1) waive any claim that they may have against the Tiverton Land Trust and the Pardon Gray Day Committee, and (2) will indemnify and hold the Tiverton Land Trust, the Pardon Gray Day Committee and their members harmless for any losses, damages, or claims, including its reasonable attorneys' fees and litigation costs, brought against any of them by any person or entity arising out of or related to the Exhibitor's participation in this event.**
